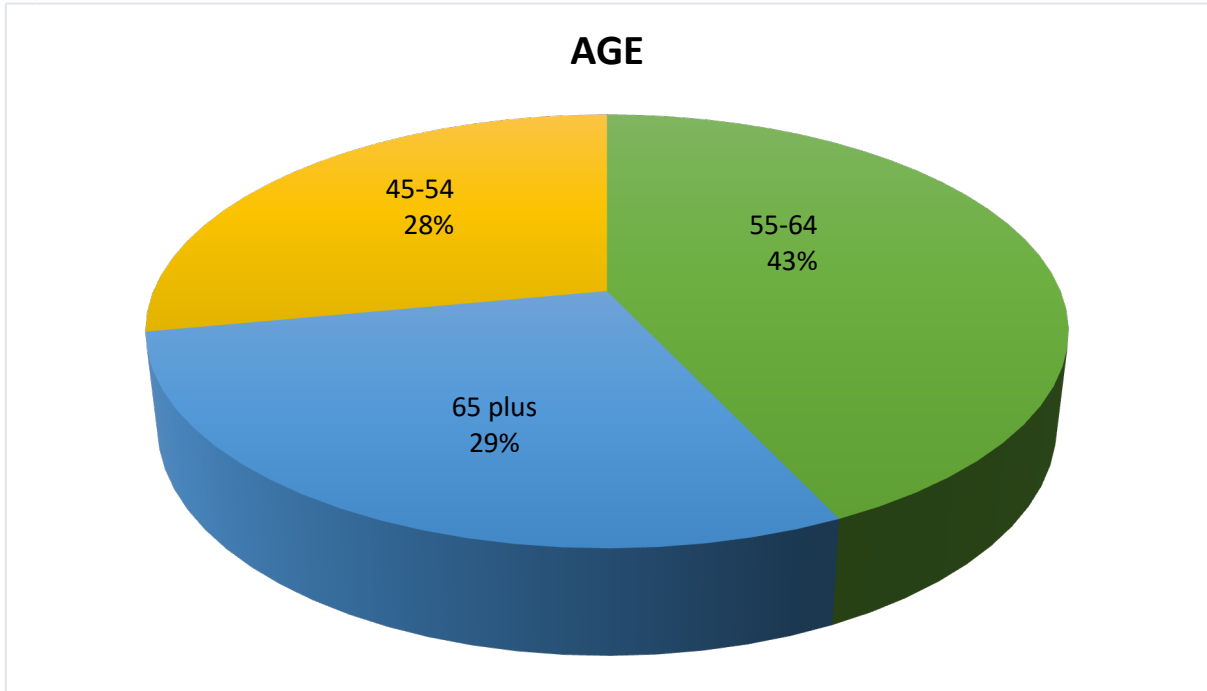
The report contains data collected in July 2024. The data was collected pursuant to the BSB Diversity Data collection rules. The survey takes place every 3 years.

Of a total workforce of 84, 75 responses were received equating to a 89% response rate. We had a 99% response rate from the staff team and a 66% response rate from members of chambers. This was an increase on the previous 2021 survey.

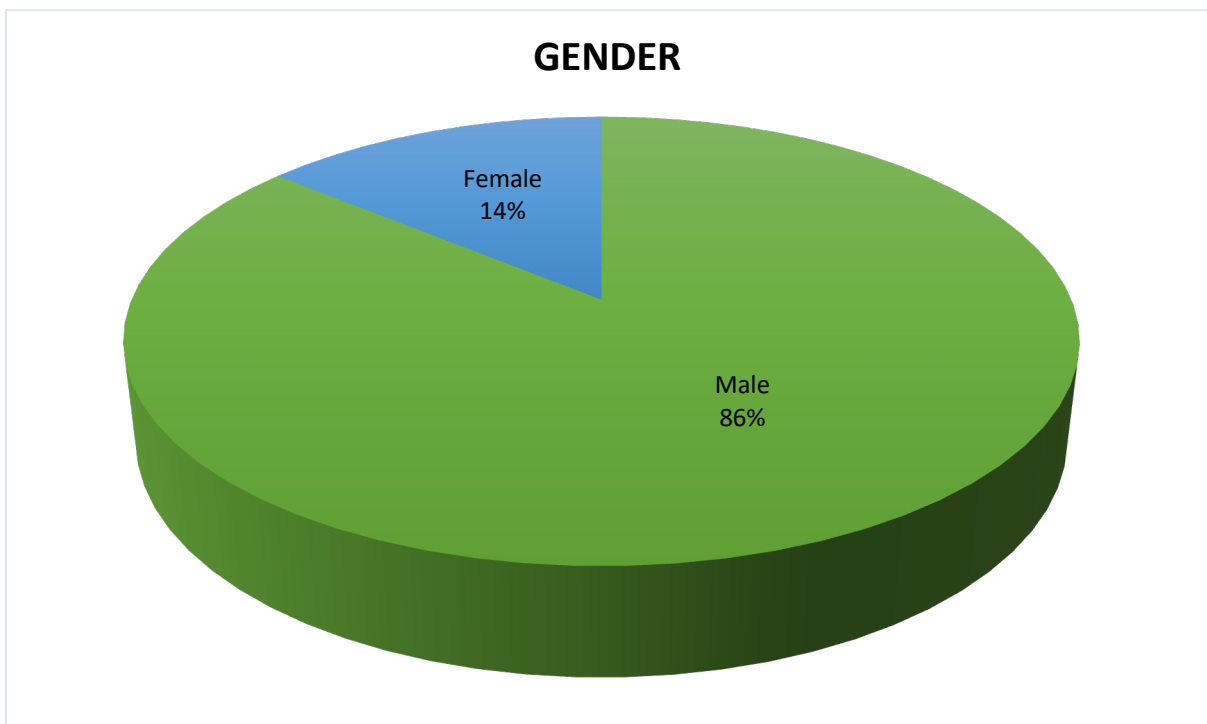
The results are based on responses received from those who participated therefore they may not reflect the entire organisation.
